

NTH 2022-2023 GotSport Player Requirements

All NTH players registered through GotSport must meet the following requirements. GotSport is the platform used by US Club Soccer and USSSA to verify player eligibility. Participation in the 2022-2023 NTH season is dependent on the following criteria:

- Player Profile Photo
- Valid Proof of Birth
- Completed Electronic Consent Waiver - League Specific
- SafeSport Core or Refresher Training (if applicable)
- Sex Offender Registry-Disqualification-Suspension Review (if applicable)

Completing GotSport Player Requirements

How to login and access your (or your child's) account:

Use the email address from your existing GotSport account or the email that was used to set up your player's account in PlayMetrics. Do not create duplicate accounts.

If this is your first time logging in, click "forgot password" to set a password.

IMPORTANT: When you login typically, parents will be accessing the system through their own user account login and not the player's (child's) profile. To find your associated players you will click "account" in the top menu bar. Next click on "family" in the left navigation bar. Click on the player and follow instructions below:

1. Upload Headshot to Player Profile

- Headshot should be shoulder up, up to date, and shot with a plain background. This will be used on match/player cards.
 - Photo size 0MB-3MB
 - Type: JPEG, JPG, PNG
 - Iphone live photos will not upload.
 - Photos must be added to the specific player (child) profile, not your own.

2. Upload Proof of Birth

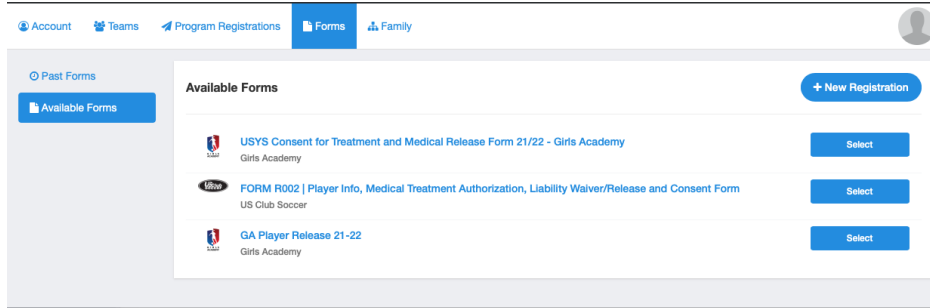

- Players' names in GotSport must be identical to proof of birth name. No nicknames. Failure to match can result in a denied proof of birth.
- Repository Name - You must select the correct Document Repository. See screenshot below. **DO NOT select NASA Tophat. That is our club, but it's not an official governing body.**

- DPL/GA - USSSA Soccer POB
- SCCL - Select US Club Soccer POB
- Academy U8-U12 - Select US Club Soccer POB

- Choose Birth Certificate or Proof of Birth for other forms of identification.

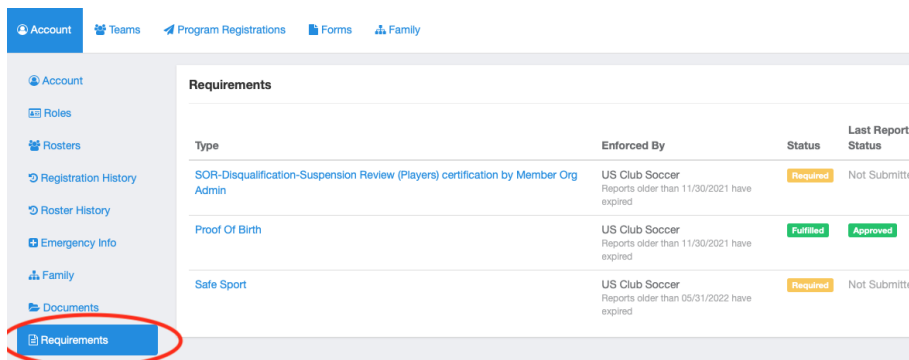
3. Complete Consent/Waiver for your league.

- SCCL and Academy (U8-U12)
 - US Club Soccer Form R-002 (Player Info, Medical Treatment Authorization, Liability Waiver/Release and Consent Form)
 - Make sure you are under your players account and click on “forms” on the top menu bar.
 - Select Form R-002. Check all boxes, sign, and date electronically.



4. SafeSport Core or Refresher Training (if applicable)

- Any players who will be 18+ years old during the applicable registration year (on or before July 31, 2023, for the 2022-23 season)
- A player's registration will not be valid, a passcard will not be issued, and the player will not appear on an Official Roster until SafeSport training (and any other applicable requirement) is completed and approved in the player's account. That means some 16- and 17-year-olds will be required to complete SafeSport Training with parental consent.
- Below is an example of the screen to reach player requirements. Click on "requirements" in left hand dashboard.



- Complete and Sync Safe Sport Training (players age 18+)

- Complete and Sync SafeSport Training (Minor Athletes/players under age 18).
 - Players will have to have consent from parent prior to completing Safe Sport

 - Note - upon completion, if the "Check Records" button is not recognizing the course has been completed, first check the email input on Safe Sport matches the email/user ID of the player's profile.

5. Sex Offender Registry-Disqualification-Suspension Review (if applicable)

- What it is: Verification that the player is not included on any of the following registries or lists, pursuant to US Club Soccer Policy 13.08, as well as U.S. Soccer and U.S. Center for SafeSport requirements:
 - the applicable sex offender registry(ies) in the relevant state (ex: state where the applicable Member Organization is located)

- the U.S. Center for SafeSport Centralized Disciplinary Database
- U.S. Soccer's Risk Management Disqualifications list (which includes US Club Soccer's)
- US Club Soccer's Suspensions list
- Completed by NTH Admin
- Applicable to:
 - Youth players who will be 18+ years old during the applicable registration year (on or before July 31, 2023, for the 2022-23 season)
 - Adult players who are on a team with a Minor Athlete (anyone who is under 18 years old).
- Timeframe: Once, at the time of initial registration once this requirement is applicable. Ongoing checks are managed by US Club Soccer.

A player's registration will not be valid, a passcard will not be issued, and the player will not appear on an Official Roster until this – and any other applicable requirement – is completed and approved.
